**Westchester Reform Temple**  
**Certification of Non-Resident Status**

In order to be eligible for Non-Resident Member status at Westchester Reform Temple ("WRT") for the 2022-23 fiscal year (July 1, 2022-June 30, 2023), the undersigned certifies that the undersigned, and each member of the undersigned's household in the case of a two-adult household (check the one that applies):

- 1. Has no residence within 100 miles from WRT (as measured by shortest driving route); or
- 2. Takes the position that the undersigned is not a resident of Connecticut, New Jersey or New York for income tax filing purposes; provided that such position is not disallowed by the relevant state.

The undersigned shall promptly advise WRT if the criterion being relied upon for eligibility of Non-Resident Member status is no longer satisfied for any reason including in the case of 2 above, the disallowance of such position by the relevant state. In such case, the undersigned shall be responsible for payment of the undiscounted dues commitment applicable to Resident Members for the relevant period.

The WRT Board has set the following commitment and security fee levels for 2021-2022\* for those eligible for Non-Resident Member status:
